On Wednesday, July 14, 2021, at 8:31 a.m., the Dayton City Commission met in regular session in the Commission Chambers of City Hall.

CALL TO ORDER

The Temporary Chairperson Commissioner Joseph called the meeting to order.

INVOCATION

Commissioner Fairchild gave the invocation.

PLEDGE OF ALLEGIANCE

The Temporary Chairperson Commissioner Joseph led the public in the Pledge of Allegiance.

ROLL CALL

Roll call was taken, and Commissioners Joseph, Mims, Shaw and Fairchild were present. The Clerk of Commission, Ms. Regina D. Blackshear, The City Manager, Ms. Shelley Dickstein and Miami Valley Interpreters, were also present.

Commissioner Mims made a motion to excuse Mayor Whaley from this week's meeting. Commissioner Fairchild seconded the motion. The motion was unanimously approved.

APPROVAL OF MINUTES

Commissioner Mims made a motion to approve the minutes from the July 7, 2021, meeting. Commissioner Fairchild seconded the motion. The previous meeting minutes were unanimously approved.

COMMUNICATIONS AND PETITIONS

There were no communications or petitions

SPECIAL AWARDS/PRESENTATIONS

The Temporary Chairperson, Commissioner Joseph, invited Ms. Joann Wright Mawasha, Deputy Director, Human Relations Council, to present on the Human Relations Council's Reorganization.

Ms. Mawasha said the Human Relations Council (HRC) works to influence and ensure a culture of fair treatment, and inclusion and equal access to opportunities for all who live, work, play, and gather in the City of Dayton.

Ms. Mawasha said the Human Relations Council was responsible for Civil Rights Enforcement, Business and Technical Assistance i.e. Procurement Enhancement Program (PEP) and Contract Compliance, Minority Business Assistance Center (MBAC) Community/Police Relations i.e. Citizen's Appeals Board and Community Police Council (CPC), and Welcome Dayton.

Ms. Mawasha said under the reorganization they will re-establish two abolished positions due to separation and pandemic: Business Technical Administrator and Senior Contract Compliance Officer. They will re-establish the abolished Executive Secretary position to assist with overall office management and administrative functions. Also, the Civil Rights Division has been rebranded, expanded, and renamed *Office of Justice and Inclusion*. Ms. Mawasha said based on the Police Reform Oversight Committee recommendations, they now have a fully staffed and funded Citizen's Appeals Board, now known as the Community Appeals Board (CAB).

Ms. Mawasha said they have partnered with the Law Department to update the Community Appeals Board (CAB) ordinance to reflect Police Reform Recommendations. She said Minority Business Assistance Center (MBAC) has received the largest grant in the program's history and expanded the capacity allowed for office assistant to move from Part-time to Fulltime. Ms. Mawasha said Welcome Dayton has been re-housed in the Department of Planning, Neighborhoods, and Development, Community Police Relations has shifted some responsibilities into the Department of Planning, Neighborhoods, and Development with a renewed HRC focus on Community Appeals Board (CAB) "Know Your Rights" campaign. She said the Community Police Council (CPC) has been relocated into several of the Police Reform Implementation Groups.

Ms. Mawasha said the benefits of the new structure include greater alignment across units related to HRC's core mission, greater alignment with the City's goals of reaching small, women, minority, and local business owners in low to moderate income areas, expanded investigative and enforcement capacity with greater awards of damages to complainants, a renewed focus in responding to human rights issues and trends, improved Community Appeals Board process, and streamlined processes to work more effectively across the organization through cross training. Ms. Mawasha said they also include enhanced opportunities and strategies to civically engage immigrant and refugee populations, opportunities to broaden and deepen partnerships and referral networks, increased opportunities for education and outreach programs around core mission, and an ongoing commitment to working with all in reducing inter-group tensions, reducing violence, and increasing safety for all who live, work, play, and gather in Dayton.

Commissioner Fairchild commended the Human Relations Council for their work and leadership.

Ms. Mawasha thanked and commended the City Commission for letting her see democracy in action and that what is being said to elected officials help move it along.

Commissioner Shaw thanked Ms. Mawasha and staff for her work.

Commissioner Mims thanked Ms. Mawasha and staff for her work and said he is especially excited about the cross-training that is being done.

Commissioner Joseph thanked Ms. Mawasha and staff for her work. He said he was looking forward to a more focused Human Relations Council.
