



TO QUALIFY TO TAKE THE JOURNEYMAN PLUMBER LICENSE EXAM

To qualify to take the Journeyman Plumber's license exam with the City of Dayton, Ohio, the applicant must show verifiable evidence of one of the following:

1. Completion of three and one-half years as an Apprentice Plumber working for a State of Ohio Licensed Plumbing Contractor or completion of three and one-half years of equivalent employment with a State of Ohio Licensed Plumbing Contractor in another locality, which has the same or equivalent qualifications as those licensed by the City of Dayton, Ohio.
2. Plumbing trade school credits of four (4) years from accredited trade school.

Verifiable proof of experience must be submitted with the application. This may be a notarized statement from a past/present employer(s), together with payroll records or tax forms of actual employment. All statements contained in the application **must be notarized**.

Completed applications will be reviewed by the Secretary, Board of Examiners of Plumbers and presented to the Board for approval. Applications will be considered by the date received. If you are approved, you will be notified approximately two weeks before the examination is scheduled.

The fee for the examination cannot be paid until the applicant has received an approval letter. If the applicant fails to appear for the examination, the application fee will be forfeited. Examinations are normally conducted once each quarter or at such times as deemed necessary. If the applicant is excused from an examination or fails an examination, the applicant must resubmit an application to be considered for a future examination.

RECIPROCITY

The City of Dayton will register a journeyman plumber if the applicant has successfully passed an examination in another locality and holds that locality's registration. The applicant needs to submit a letter from the other locality stating their examination consisted of at least a written portion containing both the design of multi-story plumbing systems and questions relating to the State of Ohio plumbing code.
